2020 Current Use Values for Georgia Conservation Use (CUVA) Land and Forest Land Protection Act (FLPA) Land

Pursuant to § 48-2-12, 48-5-7, 48-5-7.4, and 48-5-269, the Georgia Revenue Commissioner has the responsibility of annually determining the values of qualified CUVA and FLPA lands for *ad valorem* tax purposes and publishing rules and regulations to help county tax assessors determine the values of property that qualify for conservation use assessment.

The table below lists the 2020 current use values for agricultural land and timberland under CUVA and timberland under FLPA.

For example, for a piece of CUVA timberland located in Region 1 with Soil Productivity Class of 5, its current use value would be

\$619/ac. The assessed value would be \$247.60/ac (40% of assessed value). Assuming a millage rate of 25 mills, the property tax would be \$6.19/ac.
